The warehouse must be installed with lightning protection equipment. The exhaust system shall be equipped with a grounding device to conduct static electricity. Explosion proof lighting and ventilation shall be adopted. It is prohibited to use equipment and tools that are easy to generate sparks. The storage area shall be equipped with leakage emergency treatment equipment and appropriate materials.
