General advice

Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

7.1 Precautions for safe handling

Operators should be specially trained and strictly abide by the operating procedures. Operation and disposal should be carried out in a place with local ventilation or general ventilation facilities. Avoid eye and skin contact and avoid breathing vapor. See Section 8 for personal protective measures. Keep away from fire and heat sources, and smoking is strictly prohibited in the workplace. Use explosion-proof ventilation systems and equipment. If canning is required, the flow rate should be controlled, and there should be a grounding device to prevent the accumulation of static electricity. Avoid contact with incompatible substances such as oxidizing agents (see section 10 for incompatible substances). When handling, it should be lightly loaded and unloaded to prevent damage to packaging and containers. Empty containers may be harmful residues.
