7.1 Precautions for safe handling

Operators should be specially trained and strictly abide by the operating procedures. Operation and disposal should be carried out in a place with local ventilation or general ventilation facilities. Explosion proof lighting and ventilation shall be adopted. It is prohibited to use equipment and tools that are easy to generate sparks. The storage area shall be equipped with leakage emergency treatment equipment and appropriate materials.
