Dehydration, weightlessness, skin effects, and thyroid dysfunction have all been reported. Possible central nervous system effects include aphasia, blurred vision, sensory loss, seizures, etc. Repeated exposure to lithium ions can cause diarrhea, vomiting, and neuromuscular effects such as tremors, cramps, and hyperreflexia. Lithium and its compounds are lithium carbonate analogues that may cause deformities.
