Acute selenium poisoning produces central nervous system effects, which include nervousness, convulsions, and drowsiness. Chronic exposure by inhalation can produce symptoms that include pallor, coating of the tongue, anemia, irritation of the mucosa, lumbar pain, liver and spleen damage, as well as any of the other previously mentioned symptoms.
