6.1 Personal precautions, protective equipment and emergency procedures

Isolate leakage and pollution areas and restrict access. It is recommended that emergency response personnel wear dust masks, anti-virus clothes and anti-virus gloves. Don't rush into the sewer. Large amount of leakage: build a dike or dig a pit to accommodate it. Close the drainage pipe. Cover with foam to inhibit evaporation.
