6.3 Methods and materials for containment and cleaning up

Small amount of leakage: collect the leaked liquid in a sealable container as much as possible. Absorb with sand, activated carbon or other inert materials and transfer to a safe place. Don't rush into the sewer. Large amount of leakage: build a dike or dig a pit to accommodate it. Close the drainage pipe. Cover with foam to inhibit evaporation. Transfer it to tank truck or special collector with explosion-proof pump, and recycle it or transport it to waste disposal site for disposal.
