General advice

SECTION 6: Accidental release measures**6.1 Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

SECTION 7: Handling and storage**7.1 Precautions for safe handling**

Operators should be specially trained and strictly abide by the operating procedures. Operation and disposal should

be carried out in a place with local ventilation or general ventilation facilities. Avoid eye and skin contact and avoid breathing vapor. See Section 8 for personal protective measures. Keep away from fire and heat sources, and smoking is strictly prohibited in the workplace. Use explosion-proof ventilation systems and equipment. If canning is required, the flow rate should be controlled, and there should be a grounding device to prevent the accumulation of static electricity. Avoid contact with incompatible substances such as oxidizing agents (see section 10 for incompatible substances).
