General advice

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Isolate the scene of the accident and prohibit unrelated personnel from entering. Shelter and dispose of fire-fighting water to prevent pollution of the environment.
