6.1 Personal precautions, protective equipment and emergency procedures

Keep container tightly closed in a dry and well-ventilated place. Containers which are opened must be carefully resealed and kept upright to prevent leakage. Never allow product to get in contact with water during storage. Dry residue is explosive. Store under inert gas. Test for peroxide formation periodically and before distillation. Moisture sensitive; Storage temp. 2-8°C; Under Inert Atmosphere.
