Shock and kidney failure can kill you. Chronic copper poisoning includes cirrhosis of the liver, brain damage and demyelination and kidney damage; copper deposition in the Cornea Causes Wilson's disease. It was also reported that copper toxicity causes hemoglobin anemia and exacerbates arteriosclerosis. Gastrointestinal disorders, blood disorders, and possible liver damage. To the best of our knowledge, the chemical, physical and toxic properties have not been fully studied.
