If inhaled

Immediately call a poison center or doctor. Move victim to fresh air. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.

In case of skin contact

Immediately call a poison center or doctor. Remove and wash contaminated clothing before re-use. In case of contact with substance, immediately flush skin with running water for at least 20 minutes. If swallowed
