# SECTION 6: Accidental release measures

## 6.1 Personal precautions, protective equipment and emergency procedures

## 7.1 Precautions for safe handling

Operators should be specially trained and strictly abide by the operating procedures. Operation and disposal should be carried out in a place with local ventilation or general ventilation facilities. The storage area shall be equipped with leakage emergency treatment equipment and appropriate materials.
