6.1 Personal precautions, protective equipment and emergency procedures

7.1 Precautions for safe handling

Operators should be specially trained and strictly abide by the operating procedures. Operation and disposal should be carried out in a place with local ventilation or general ventilation facilities. Avoid eye and skin contact and avoid breathing vapor. See Section 8 for personal protective measures. Keep away from fire and heat sources, and smoking is strictly prohibited in the workplace. Use explosion-proof ventilation systems and equipment.
