7.1 Precautions for safe handling

Operators should be specially trained and strictly abide by the operating procedures. Operation and disposal should be carried out in a place with local ventilation or general ventilation facilities. Avoid eye and skin contact and avoid breathing vapor. See Section 8 for personal protective measures. Keep away from fire and heat sources, and smoking is strictly prohibited in the workplace. Use explosion-proof ventilation systems and equipment. If canning is required, the flow rate should be controlled, and there should be a grounding device to prevent the accumulation of static electricity.
