Repeated exposure to lithium ions can cause diarrhea, vomiting, and neuromuscular effects, such as tremors, spasms, and hyperreflexia., Brominated rash, especially on the face, such as acne and boils, often occurs when the inhalation time of bromide is prolonged, Acute symptoms caused by excessive exposure include depression, schizophrenia
