4.2 Most important symptoms and effects, both acute and delayed

High concentration of lithium ions can cause dizziness and collapse, and if sodium intake is limited, it can cause kidney damage. Dehydration, weightlessness, skin effect and thyroid dysfunction have been reported. The possible central nervous system effects include aphasia, blurred vision, sensory loss, convulsions and so on. Repeated exposure to lithium ions can cause diarrhea, vomiting and neuromuscular effects such as tremor, cramps and hyperreflexia. Lithium and its compounds are lithium carbonate analogues and may cause teratogenicity. The data is positive in animal test, and suspicious positive in human. As far as we know, the chemical, physical and toxic properties have not been completely studied.
