Long term exposure to iodide may lead to iodine poisoning in sensitive populations. Symptoms after contact include rash, runny nose, headache, and mucosal irritation. In severe cases, the skin may develop papules, boils, measles, blisters, and blue spots. Iodide easily passes through the placenta. Thyroid swelling has also been reported to cause breathing difficulties and lead to neonatal death. It is known that iodide causes drug-induced fever, which usually lasts for a short period of time.
