Early symptoms include weakness, drowsiness, and leg weakness. In more cases, facial numbness and mask like sensations may occur, as well as emotional outbursts such as uncontrollable laughter and spasms while walking, which can lead to falls. Pneumonia is occasionally found among workers who are frequently exposed to manganese compound dust., To our knowledge, the chemical, physical, and toxic properties of this

substance have not been fully studied.
