6.1 Personal precautions, protective equipment and emergency procedures

Small amount of leakage: collect the leaking liquid in a sealable container as much as possible. Absorb with sand, activated carbon or other inert materials and transfer to a safe place. Do not flush into the sewer. A large number of leaks: construct a dike or dig a pit for storage. Close the drainage pipe. Cover with foam to prevent evaporation. Use explosion-proof pump to transfer to tank truck or special collector, recycle or transport to waste disposal site for disposal.
