6.1 Personal precautions, protective equipment and emergency procedures

Small amount of leakage: collect the leaked liquid in airtight containers as far as possible. Absorb with sand, activated carbon or other inert materials and transfer to a safe place. Do not flush into the sewer. Massive leakage: build a dike or dig a pit for storage. Close the drainage pipe. Cover with foam to inhibit evaporation. Use explosion-proof pump to transfer to tank car or special collector, recycle or transport to waste disposal site for disposal.
