General advice

If inhaled

flammability. Its vapor mixed with air can form an explosive mixture, which is extremely flammable or explosive in case of open flames and high heat. Combustion produces toxic carbon monoxide gas. In high-temperature fires, a heated container or storage tank is in danger of cracking and exploding. Steam is heavier than air, can spread to a considerable distance at a lower place, and will rekindle and explode (flash explosion) when encountering a fire source.
