Rats exhibit abnormal reactions, which are more likely to occur in the eyes and bladder of the animals. Rats are fed. After 24 days, it showed: hyperbilirubinemia, growth retardation, hypoglycemia, mitochondrial dysfunction, increased liver mass, large number of lobular center necrosis in rats after death at lethal dose (6-11 days), infection response in the parenchyma, and fat changes in living cells.
