SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

It is recommended that emergency personnel wear air-contained breathing apparatus, anti-static clothing, and rubber and oil-resistant gloves. Do not touch or cross the spill. All equipment used during operation should be grounded. Cut off the source of leakage as much as possible. Eliminate all ignition sources. Delimit the warning zone according to the influence area of liquid flow, steam or dust diffusion, and evacuate unrelated personnel from the crosswind and upwind to the safe zone

6.2 Environmental precautions

Contain leaks to avoid environmental pollution. Prevent leaks from entering sewers, surface water and groundwater.

6.3 Methods and materials for containment and cleaning up

Small amount of leakage: collect the leaking liquid in a sealable container as much as possible. Absorb with sand, activated carbon or other inert materials and transfer to a safe place. Do not flush into the sewer. A large number of leaks: build a dike or dig a pit for storage. Close the drainage pipe. Cover with foam to prevent evaporation. Use explosion-proof pump to transfer to tank truck or special collector, recycle or transport to waste disposal site for disposal.

SECTION 7: Handling and storage

7.1 Precautions for safe handling

Operators should be specially trained and strictly abide by the operating procedures. Operation and disposal should be carried out in a place with local ventilation or comprehensive ventilation facilities. Avoid contact with eyes and skin, and avoid inhalation of steam. See section 8 for personal protective measures. Keep away from fire and heat sources, and smoking is strictly prohibited in the workplace. Use explosion-proof ventilation systems and equipment. If canning is required, the flow rate should be controlled, and there should be a grounding device to prevent static electricity from accumulating. Avoid contact with incompatible materials such as oxidants (refer to section 10 for incompatible materials). When handling, load and unload with care to prevent damage to packaging and containers.
