reproductive ability. Exposure to thiocarbamate or thiram, even in small amounts of alcohol, can cause facial flushing, difficulty breathing, nausea, vomiting, and hypotension. The sensitivity to alcohol caused by exposure to these compounds may last for 6-14 days. Severe cross toxicity was observed in rats fed with tetraethyl thiram and exposed to 1,2-dibromoethane vapor. NIOSH reported similar cross toxicity occurring in compounds related to the chemical structure of tetraethyl thiuram and other halogenated carbons.
