6.1 Personal precautions, protective equipment and emergency procedures

It is recommended that emergency personnel wear air-contained breathing apparatus, anti-static clothing, and rubber and oil-resistant gloves. Do not touch or cross the spill. All equipment used during operation should be grounded. Cut off the source of leakage as much as possible. Eliminate all ignition sources. According to the area affected by liquid

flow, steam or dust diffusion, the warning zone shall be delineated, and irrelevant personnel shall be evacuated from the crosswind and upwind direction to the safe area.

6.3 Methods and materials for containment and cleaning up

Small amount of leakage: collect the leaking liquid in a sealable container as much as possible. Absorb with sand, activated carbon or other inert materials and transfer to a safe place. Do not flush into the sewer. A large number of leaks: build a dike or dig a pit for storage. Close the drainage pipe. Cover with foam to prevent evaporation. Use explosion-proof pump to transfer to tanker or special collector, recycle or transport to waste disposal site for disposal

7.1 Precautions for safe handling

Operators should be specially trained and strictly abide by the operating procedures. Operation and disposal should be carried out in a place with local ventilation or comprehensive ventilation facilities. Avoid contact with eyes and skin, and avoid inhalation of steam. See section 8 for personal protective measures. Keep away from fire and heat sources, and smoking is strictly prohibited in the workplace. Use explosion-proof ventilation systems and equipment.
